User will accept all responsibilities for any damage to the premises, furniture, equipment or grounds resulting from the use of the facility by me or my guests.

1) All Food, beverage and serving supplies must be provided by the Host of the Event. The Event Host is responsible for all set up and cleaning of the facilities. Cleaning includes resetting of all furnishings, countertops, sink and tables, as well as emptying all garbage containers into the dumpster located in the parking lot. **Please no leftover food left in the refrigerator.**

2) The greens may not be used for any purpose other than lawn bowling. Bowlers must wear flat-soled shoes (tennis shoes preferred) without any protruding heel. Treads deeper than 1/8 inch may damage the green surface and are not allowed.

3) I understand that I may be subject to photograph and/or video on the premises, and I agree to allow my photo, video or likeness to be used for legitimate purposes by NHLBC, media sources, without payment or any other form of compensation.
